

RESOLUTION NO. 204834

FEB 8 1972

WHEREAS, on July 30, 1968, Resolution No. 194342 was adopted which granted a 60% property owner petition for the improvement of the public right of way and on private property in LA JOLLA CORONA ESTATES UNIT NOS. 2 AND 3 for the conversion of existing overhead power and communication facilities under the provisions of the Improvement Act of 1913; and

WHEREAS, an opposing petition was subsequently filed with the City Clerk reducing the number of owners in favor of the project to less than 60%; and

WHEREAS, further processing of the project was deferred in view of this opposition; and

WHEREAS, the City conducted a post card poll in November 1971 to determine the community's desire regarding the project; and


WHEREAS, the poll indicated that 43.1% of the property owners were opposed to the project, 27.2% were in favor, and 29.7% failed to respond; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Resolution No. 194342, adopted July 30, 1968, granting the petition for the above-mentioned improvements be, and it is hereby rescinded.
