BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the State of California for the engineering design, construction and maintenance of revised traffic signal and safety lighting systems and channelization at Gates No. 3 and No. 6 of the U. S. Naval Training Center from North Harbor Drive to Lytton Street on State Highway Route 209 (Rosecrans Street). (Form of Agreement filed in the office of the City Clerk as Document No. 738950.)

BE IT FURTHER RESOLVED, that the expenditure of \$10,000 is hereby authorized from Gas Tax Funds solely and exclusively for the purpose of providing funds for the work described above and related costs.
