BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a lease agreement with Larwin-San Diego, Inc., a land developer, for a temporary fire facility on Lot No. 1114, Larwin-Mesa View, Unit No. 12, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 738958.

BE IT FURTHER RESOLVED, that the sum of \$12,500 be transferred from the General Fund Unallocated Reserve (100) to the Fire Department (16.03) solely and exclusively for the purpose of supplying supervisory personnel, station furnishings and other supplies for the above based temporary fire station facility.
