BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an Amendment to Sublease affecting that certain Sublease between the STATE OF CALIFORNIA, by and through its duly appointed, qualified and acting Director of General Services, and THE CITY OF SAN DIEGO, sublessee, a form of which Sublease is on file in the office of the City Clerk as Document No. 731977, for the leasing of space at 4235 National Avenue, San Diego, California, by the Model Cities Program, to (1) increase the leased premises from 1,300 square feet to 4,062 square feet, and (2) increase the rental to \$934.26 per month from May 1, 1971 to November 1, 1971, \$1,194.20 for the month of November 1971, and \$1,421.70 per month thereafter during said term, under the terms and conditions set forth in the form of Amendment to Sublease, on file in the office of the City Clerk as Document No. 738959.
