BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. Standard Oil Company of California, Western Operations, Inc. 2. Barnicle Oil Co. 3. Pepper Oil Company, Inc. 4. Union Oil Company of California are hereby accepted, and the City Manager is hereby authorized to execute contracts for the purchase of MISCELLANEOUS PETROLEUM PRODUCTS, INCLUDING GASOLINE, DIESEL OIL, FUEL OIL, KEROSENE AND LUBRICATING OILS AND GREASES as may be required for the period of one year beginning February 16, 1972 through February 15, 1973, per prices on file in the Purchasing Department as follows:

1. Standard Oil Company of California, Western Operations, Inc. for Section I - Regular and Ethyl bulk gasoline and credit card gasoline at State of California contract prices and Section II, Item 3a, Kerosene delivered in five gallon containers; terms net 30 days;
2. Barnicle Oil Co. for Section II, Item 1, Diesel Oil; terms net 30 days;
3. Pepper Oil Company, Inc. for Section II, Items 2 and 3, Fuel Oil and Kerosene delivered in bulk; terms  $\frac{1}{4}$  of 1%, 30 days, and;
4. Union Oil Company of California for Section III - Lubricating Oils and Greases; terms net 30 days.
