WHEREAS, The City of San Diego is the owner of a portion of the Southwesterly Quarter of Quarter Section 83 of Rancho de la Nacion, according to Map thereof No. 166, filed in the office of the San Diego County Recorder; and

WHEREAS, Joan Demby Fauquier, the owner of the adjoining land, has requested that the City convey to her all of the City's interest in and to a portion of the Southwesterly Quarter of Quarter Section 83 of Rancho de la Nacion; and

WHEREAS, said land was acquired for utility purposes and has been determined surplus by the Utilities Director of said City as long as the City retains an easement for water pipeline purposes; and

WHEREAS, the deed conveying said property will reserve an easement for pipeline purposes; and

WHEREAS, the City desires to negotiate the sale of said land to Joan Demby Fauquier, under the provisions of Section 22.0902 (e) of the San Diego Municipal Code, which permit the sale of real property belonging to The City of San Diego by negotiation; and

- 3. That no broker's commission shall be paid by City on the herein-described sale.

4. That the City Clerk of said City is hereby authorized and directed to deliver said deed to the Property Director of said City for further handling.
