WHEREAS, on November 24, 1971, at a public hearing, the Housing Advisory and Appeals Board approved said findings;

as follows:

1. The building situate on the property described above is declared to be a public nuisance.

2. The City Attorney is authorized and instructed to take appropriate legal action to abate the aforesaid nuisance.
