

RESOLUTION NO. 204887

WHEREAS, San Diego's taxicab owners have in April of 1971 and January of 1972, petitioned the Council for authority to increase their fares; and

WHEREAS, Section 72.02(a) provides that the City Council shall, by resolution after a hearing, establish just and reasonable rates for the hire of taxicabs; and

WHEREAS, it is in the best interests of all parties to be in possession of written reports concerning the financial status of San Diego's taxicab operators and the various proposals for rate relief as submitted by the City Manager and the taxicab operators, at least ten (10) days prior to the hearing; and

WHEREAS, it is the intent of the Council to set a date certain for hearing, at which time all interested parties may be heard; and

WHEREAS, it is the express desire of the City Council to give public notice of said meetings; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. March 9, 1972 at 2 p.m. is hereby set as the date and time certain for public hearings to establish just and reasonable rates for hire of taxicabs within the City of San Diego pursuant to Section 72.02 of the San Diego Municipal Code.

2. 5 p.m., of February 25, 1972, is set as the deadline for the submission of written reports, statistical analysis, and other written material concerning the establishment of just and reasonable rates for the hire of taxicabs, said written matter to be filed in the office of the City Clerk of The City of San Diego.

3. The City Clerk of The City of San Diego shall make available for inspection at his office all materials so filed.

4. The City Clerk is further directed to publish this resolution in the San Diego Union, the San Diego Tribune and the San Diego Daily Transcript upon adoption of this resolution, and for three (3) days prior to the date of hearing.
