RESOLUTION NO. 204894

APPROVING MAP OF WESTWOOD UNIT NO. 8 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by LEO H. BARBOUR, Registered Civil Engineer, and entitled "WESTWOOD UNIT NO. 8 Being a subdivision of a portion of Rancho San Bernardo, in the City of San Diego, County of San Diego, State of California, according to Map thereof recorded in Book 2, Page 462 of Patents, records of said County. Together with a portion of West Bernardo Drive.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said Map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets and portions of public streets, to wit: Hada Drive, Matinal Drive, Luz Place, Cabela Drive, a portion of Duenda Road, and a portion of West Bernardo Drive for public purposes and said streets and portions of streets are hereby declared to be public streets and portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to West Bernardo Drive, adjacent

and contiguous to Lots 412, 413, 414, 415, 416, 417, 418, 419, 420, 421 and 422, all as granted and shown on said Map.

The Clerk of said City is hereby authorized and directed to endorse upon said Map, as and for the act of the Council, that said Council has approved said subdivision Map and that said public streets and portions of public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access as granted and shown on this Map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said Map to the Clerk of the Board of Supervisors of the County of San Diego, California.
