RESOLUTION NO. 204896

APPROVING MAP OF GATEWAY UNIT NO. 2 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council finds that that certain map surveyed by  
GARY L. McCABE, Registered Civil Engineer, and entitled  
"GATEWAY UNIT NO. 2 Being a subdivision of a portion of the  
North half of the Northwest Quarter of the Northwest Quarter of  
Section 6, Township 15 South, Range 2 West, San Bernardino  
Meridian, in the City of San Diego, County of San Diego, State  
of California, according to official plat thereof.", is made  
in the manner and form prescribed by law and conforms to the  
surrounding surveys; that said Map and the subdivision of land  
shown thereon is hereby approved and accepted; and said Council  
hereby accepts on behalf of the public, the public streets and  
portion of public street, to wit: Helenjames Avenue, Covina  
Street, and a portion of Gold Coast Drive, for public purposes,  
and said streets and portion of street are hereby declared to  
be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on  
behalf of The City of San Diego, a municipal corporation, the  
easement with the right of ingress and egress for the construction  
and maintenance of drainage facilities, as granted and shown on  
said Map, and subject to the conditions as set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portion of street are accepted on behalf of the public as heretofore stated; and that those certain easements with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
