as follows:



PATTERSON, Registered Civil Engineer, and entitled, "MIRA MESA SHOPPING CENTER UNIT NO. 4 Being a subdivision of a portion of Section 36, Township 14 South, Range 3 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to United States Government Survey: together with portions of New Salem Street, Camino Ruiz, and Mira Mesa Boulevard as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map.
