

RESOLUTION No. 204908

Adopted by FEB 17 1972

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That Hancock Street shall be a one-way street north-westbound from Rosecrans Street to Kurtz Street, Kurtz Street shall be a one-way street south-eastbound from its intersection with Hancock Street to Rosecrans Street, Riley Street shall be a one-way street westbound between Hancock Street and Kurtz Street.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City forces all the work necessary to convert Hancock Street, Kurtz Street and Riley Street to one-way streets, as described above.

BE IT FURTHER RESOLVED, that the expenditure of \$4,000 is hereby authorized from Gas Tax Funds solely and exclusively for the purpose of providing funds for the work described above and related costs.
