That the bid of \$29,615.00 by DBX, Inc., dba Perry Electric, a corporation, for the CONSTRUCTION OF TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT THE INTERSECTION OF RANCHO BERNARDO ROAD AND BERNARDO OAKS DRIVE, including Additive Alternate "A", in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 738442.
