1. The Dye House to dye approximately 24,000 SQUARE FEET OF DRAPES @ .075¢ per square foot for a total cost of \$1,800.00; terms 1% 30 days.
2. California Fire Extinguisher and Flameproofing Corp. to flameproof approximately 24,000 SQUARE FEET OF DRAPES @ .06¢ per square foot for a total cost of \$1,440.00; terms 1% 30 days.
