RESOLUTION AWARDING A CONTRACT TO IMPROVE SPRUCE STREET, ALLEY IN BLOCK 10, LA MESA COLONY, AND ALLEY IN BLOCK 17, SUBDIVISION OF LOTS 20 TO 50, BLOCK N, TERALTA.
