
Adopted by FEB 22 1972

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of F-M SQUARE MIRAMAR, a partnership, executed in favor of The City of San Diego, bearing date December 20, 1971, conveying to said City an easement and right of way for street purposes through, over and across the Northwest Quarter of Section 12, Township 15 South, Range 3 West, San Bernardino Base and Meridian, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named EMPIRE STREET.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
