BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City a Lease Agreement with WOODWARD SAND COMPANY, INC., as lessee, leasing a portion of Tract "B" of Rancho El Cajon, consisting of approximately 20 acres, for a term of three (3) years ending January 31, 1975, at a rental of \$0.36 per cubic yard of sand removed or \$500.00 per month, whichever amount is greater, for the purpose of sand removal, under the terms and conditions set forth in the form of Lease Agreement, on file in the office of the City Clerk as Document No. 739094.
