RESOLUTION NO. 204963

WHEREAS, an Employer-Employee Relations Policy has been established for The City of San Diego; and

WHEREAS, Section XI of said policy requires that the City Council establish most appropriate units after review of petitions filed by employee organizations and after recommendation by the Management Team; and

WHEREAS, several petitions have been received from employee organizations and reviewed by the Management Team; and

WHEREAS, several meetings in relation thereto have been conducted between the Management Team and the affected employee organizations; and

WHEREAS, as a result of said review and meetings, the Management Team recommends to the Council six units among City classified general service employees as being most appropriate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council hereby finds that the following six units among classified general service personnel in various departments of The City of San Diego be and the same are hereby determined to be most appropriate:

1. Supervisory
2. Professional
3. Administrative Support and Field Services

4. Technical
5. Skilled Trades and Equipment Operation
6. Maintenance and Labor

BE IT FURTHER RESOLVED, that, with the exception of certain confidential employees to be designated, job classifications to be included within each most appropriate unit shall be as specified in the Report to Council dated February 22, 1972, on file in the office of the City Clerk as Document No. 739127.
