That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with GUY WINTON, JR., Consulting Civil Engineer, for engineering services in connection with the design and construction of portions of MENDOCINO BOULEVARD, NOELL STREET, BROAD AVENUE, ROBINSON STREET, ARCHER STREET and IMPERIAL AVENUE, in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No.

739134 .

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$7,000 within General Fund 100 from the Unallocated Reserve (53.30) to the Reserve for Ordinances and Resolutions (53.20), and that expenditure of said funds is hereby authorized solely and exclusively for the purpose of providing funds for payment of services of GUY WINTON, JR., in connection with the project described above.
