APPROVING MAP OF HIDDEN VALLEY ADDITION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by E. F. COOK, Registered Civil Engineer, and entitled "HIDDEN VALLEY ADDITION Being a subdivision of a portion of Lot 1288 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to the Map thereof made by James Pascoe in 1870, a copy of which said Map was filed in the office of the Recorder of San Diego County, November 14, 1921 and is known as Miscellaneous Map No. 36 and Lot 24 of Hidden Valley Map No. 6862, filed in the office of the Recorder of San Diego County, February 26, 1971.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said Map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that the said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, those easements listed in the certificate signed by the Owners for general utility and access purposes and for access, utility and drainage purposes, subject to the conditions expressed therein.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that

said Council has approved said subdivision map and those certain easements listed in the certificate signed by the Owners, subject to the conditions expressed therein, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
