APPROVING MAP OF VILLA MONSERATE UNIT NO. 6 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by E. F. COOK, Registered Civil Engineer, and entitled, "VILLA MONSERATE UNIT NO. 6 Being a subdivision of portion of Lots 5, 6, 9, and 10 of Rosedale Tract in the City of San Diego, County of San Diego, State of California, according to Map No. 825, filed in the office of the County Recorder of San Diego County, January 21, 1897, together with a portion of Clairemont Mesa Boulevard as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said Map and the subdivision of land shown thereon is hereby approved and accepted.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the open space easement over all of Lot 495 as granted and shown on said map and subject to the conditions set forth thereon.

space easement over all of Lot 495 as granted and shown on this map within this subdivision is accepted on behalf of The City of San Diego, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
