BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$22,654.00 by V. E. Posey, An Individual, for the CONSTRUCTION OF CALIFORNIA STREET DRAIN in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 738642.
2. Authorizing the City Manager to execute a license agreement with The Atchison, Topeka and Santa Fe Railway Company for that portion of work in California Street that lies within the railway company's right-of-way.
3. That the expenditure of \$27,500.00 is hereby authorized out of the Storm Drain and Flood Control Bond Fund (727) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF CALIFORNIA STREET DRAIN in the City of San Diego, and related costs.
