WHEREAS, The City of San Diego is the owner of a portion of Lot A, Del Cerro Unit No. 1, according to Map thereof No. 3222, filed April 29, 1955, in the office of the San Diego County Recorder; and

WHEREAS, the San Diego Gas & Electric Company, a corporation, has requested the conveyance of an easement for underground facilities across said property to provide electrical service to City's water pumping station; and

WHEREAS, the purposes for which the easement is required are public purposes; and

WHEREAS, Section 22.0907 of the San Diego Municipal Code authorizes the conveyance of City property to public agencies for public purposes without complying with the provisions relating to the advertising for bids and auction sales contained in the Municipal Code; and

WHEREAS, the City Manager, pursuant to Section 22.0907 of the San Diego Municipal Code, has recommended that said easement be conveyed to the San Diego Gas & Electric Company, a corporation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That, in consideration of the benefits to accrue to the people of said City, the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to

execute, for and on behalf of The City of San Diego, a deed conveying to the SAN DIEGO GAS & ELECTRIC COMPANY, a corporation, an easement for the purpose of underground electrical facilities across a portion of Lot A, Del Cerro Unit No. 1, according to Map thereof No. 3222, filed April 29, 1955, in the office of the San Diego County Recorder, as more particularly described in the form of Deed of Easement, on file in the office of the City Clerk as Document No.
