BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of AVCO COMMUNITY DEVELOPERS, INC., a California corporation, who acquired title as RANCHO BERNARDO, Inc., a California corporation, executed in favor of The City of San Diego, bearing date, January 25, 1972, conveying to said City an easement and right of way for street purposes through, over and across all that portion of Lot 2044, Gatewood Hills Unit No. 5, according to the Map thereof No. 6677, filed in the Office of the Recorder of San Diego County, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named UTOPIA ROAD.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
