Adopted on FEB 29 1972


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of BRUCE FARLEY CORPORATION, a California corporation, executed in favor of The City of San Diego, bearing date December 30, 1971, conveying to said City an easement and right of way for alley purposes through, over and across the Southerly 5.00 feet of Lots 17, 18, 19 and 20, Block 5, McLaren's "H" Street Addition, according to the Map thereof No. 291, filed July 27, 1887 in the Office of the San Diego County Recorder, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public alley.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
