

**RESOLUTION No. 205008**

Adopted on FEB 29 1972

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of PARDEE CONSTRUCTION COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date November 2, 1971, conveying to said City an easement and right of way for street purposes through, over and across all that portion of the Northeast Quarter of Section 25, Township 14 South, Range 3 West, San Bernardino Base and Meridian, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named CAMINO RUIZ, and the land therein conveyed as Parcel 2 is hereby dedicated as and for a public street and the same is hereby named ZAPATA AVENUE, and the land therein conveyed as Parcel 3 is hereby dedicated as and for a public street and the same is hereby named KELOWNA ROAD.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
