

RESOLUTION No. 205009

Adopted by FEB 29 1972

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of, MAURICE PERLSTEIN and MYNA PERLSTEIN, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date May 18, 1971, conveying to said City an easement and right of way for street purposes through, over and across those portions of Lot "D" of Resubdivision of La Jolla Hills No. 2, according to Map thereof No. 2087 filed in the office of the County Recorder of San Diego County, and of Pueblo Lot 1287 of the Pueblo Lands of San Diego, according to Map thereof made by James Pascoe in 1870, being in the City of San Diego, County of San Diego, State of California, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named HILLSIDE DRIVE.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
