

RESOLUTION No. 205010

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of, The SAN DIEGO UNIFIED SCHOOL DISTRICT OF SAN DIEGO COUNTY, CALIFORNIA, executed in favor of The City of San Diego, bearing date, November 23, 1971, conveying to said City an easement and right of way for street purposes through, over and across all that portion of Lot 1, Block 4 of Chesterton Extension according to Map thereof No. 2062, filed September 30, 1927 in the Office of the San Diego County Recorder, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named WHEATLEY STREET.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder, of San Diego County.
