RESOLUTION NO. 205015 FEB 2 9 1972

WHEREAS, members of the City Council of The City of San Diego, the City Attorney and the City Manager are frequently required to travel within the greater metropolitan area of the City of San Diego in order to attend meetings and perform other duties in the discharge of their offices; and

WHEREAS, the only convenient and expeditious means of transportation available to these officials are either their personal automobiles or automobiles placed at their disposal by the City; and

WHEREAS, it has long been the policy of the City that each member of the Council, the City Attorney and the City Manager shall have at their disposal automobiles in which to travel as required in the proper discharge of their official duties; and

WHEREAS, the constantly increasing geographic size and population of the City require greater expense by these officials in the discharge of their official duties; and

WHEREAS, previous resolutions of this Council have determined and set a fair average amount representing personal automobile expense paid by each of these officials in the discharge of his official duties; and

WHEREAS, it is the continuing policy of the City to recognize the necessity for each member of the Council, the City Attorney and the City Manager to have at their disposal automobiles in which to travel incident to the discharge of their official duties; and

WHEREAS, it is also the continuing policy of the City to recognize that these officials should be reimbursed for such necessary expenditures; and

WHEREAS, increased costs in the maintenance and operation of automobiles since the last automobile allowance revision on February 11, 1969, has made the present \$180 per month automobile allowance for members of the City Council, the City Attorney and the City Manager unrealistically low; and

WHEREAS, studies made by the Budget Department of said
City estimate that \$216 per month is a reasonable amount to
reimburse members of the City Council, the City Attorney
and the City Manager for their costs in operating an
automobile used in connection with their official duties; and

WHEREAS, application has been filed with the Price
Commission under the President's Economic Stabilization
Program to permit payment of \$216 a month as an automobile
allowance for members of the City Council, the City Attorney
and the City Manager; and

WHEREAS, the initial increase proposed herein does not exceed 5.5 percent, NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That commencing on March 1, 1972, each member of the City Council, the City Attorney and the City Manager shall receive the sum of one hundred eighty-nine and 90/100 dollars (\$189.90) per month as reimbursement for expenses necessarily incurred in the operation of their personal automobiles in the performance of their official duties and that this sum shall be automatically increased to two hundred sixteen dollars (\$216) per month or such lesser amount as may be approved when and if the President's Pay Board approves said monthly automobile allowance increase to \$216 or any lesser amount; or as an alternate, at the election of each member of the Council, the City Attorney and the City Manager, and in lieu of the sum of one hundred eightynine and 90/100 dollars (\$189.90) per month reimbursement for automobile expenses or two hundred sixteen dollars (\$216) per month under the above conditions, each such official so electing shall receive the sum of fifty-two and 75/100 dollars (\$52.75) per month and shall have placed at his disposal a City-owned or leased automobile to be used in the performance of his official duties.

BE IT FURTHER RESOLVED, that Resolution No. 196032, passed and adopted February 11, 1969, is hereby rescinded. APPROVED: JOHN W. WITT, City Attorney
