1. 2. That this Council does hereby commend the Rotary Club of Pacific Beach for this act of civic generosity and does hereby publicly express on behalf of the citizens of this City a debt of gratitude to the Rotary Club of Pacific Beach.

3. That the expenditure of two thousand dollars is hereby authorized from Capital Outlay Fund 245 solely and exclusively for providing funds as specified above and related costs.
