APPROVING MAP OF VILLA BARBADOS NORTH UNIT NO. 1 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by E. F. COOK, Registered Civil Engineer, and entitled "VILLA BARBADOS NORTH UNIT NO. 1 Being a subdivision of portions of Lots 5, 6, 7, and 8, the street Westerly of Lots 5, 6, and 7, as vacated to public use of Rosedale Tract according to Map thereof No. 825, filed in the office of the County Recorder of San Diego County, January 21, 1897, also a portion of Lot 73 of partition of Rancho Mission of San Diego Map No. 330, S.C.C. No. 348 together with a portion of Santo Road as dedicated to public use, all in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets and portion of public street, to wit: La Morada Court, La Morada Drive, El Comal Drive, Salacot Court, Despejo Place, Torca Court, Amaro Drive, and a portion of Santo Road for public purposes and said streets and portion of street are hereby declared to be public streets and portion of public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters rights of access in and to Santo Road adjacent and contiguous to Lots 1, 148, 147, 144 and 143, all as granted and shown on said map.


BE IT FURTHER RESOLVED, that said Council accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of The City of San Diego, a municipal corporation, the open space easement over portions of Lots 1, 143, 144, 147, 148, 112, 113, 149 and all of Lot 151, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council that said Council has approved said subdivision map and that said public streets and portion of public street are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with the easement with the right of ingress and egress for the construction and maintenance of drainage facilities and the easement for open space as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
