

RESOLUTION No. 205072

Adopted by MAR 7 1972

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That an easement for the purpose of a right of way for the construction, operation and maintenance of a storm drain or drains and appurtenances thereto, through, over, under, along and across the hereinafter described property, be, and the same is hereby set aside for such public purposes:


All that portion of Lot 8, Block 16 of the resubdivision of Lots 14, 16, 18, 19 and 20 of Rosedale Tract in the City of San Diego, County of San Diego, State of California according to Map thereof No. 857 filed in the Office of the Recorder of San Diego County being a strip of land 10.00 feet in width lying 5.00 feet on each side of the following described centerline:

Commencing at the Northeast corner of Lot B of Villa Barbados Unit No. 2 according to Map thereof No. 6898 filed in said County Recorder's Office April 13, 1971 thence North 76°46'03" East, 52.50 feet to the TRUE POINT OF BEGINNING; thence North 18°46'00" East, 350.00 feet to a point of terminus.

The sidelines of the above described strip of land shall be prolonged or shortened so as to terminate Southerly in a line that bears North 76°46'03" East through the TRUE POINT OF BEGINNING.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to file a certified copy of this resolution in the office of the County Recorder of San Diego County.
