

RESOLUTION NO. 205073

WHEREAS, the Division of Highways, Department of Public Works, State of California is in the process of acquiring rights of way for the purpose of the construction of State Highway 11-SD-805, in the City of San Diego; and

WHEREAS, a portion of said proposed freeway crosses a portion of the Southeast Quarter of the Southwest Quarter of Section 36, Township 18 South, Range 2 West, S.B.M., according to United States Government Survey approved February 25, 1870; and

WHEREAS, said Division of Highways, Department of Public Works, State of California, has requested that the City quitclaim to them any interest it may have in said portion of the Southeast Quarter of the Southwest Quarter of Section 36; and

WHEREAS, said Division of Highways, Department of Public Works, State of California, has offered to pay to the City the sum of One Hundred Dollars (\$100.00) for a quitclaim deed quitclaiming any interest the City may have in said land, as more particularly described in said quitclaim deed; and

WHEREAS, it is in the public interest that the City quitclaim to said Division of Highways, Department of Public Works, State of California, any interest it may have in said land, and the City Manager has recommended it; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager of said City be, and he is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Right of way Contract-- State Highway No. 22549-B, with the State of California, Department of Public Works, Division of Highways, covering the quitclaiming by the City to the State of California of all its interest in a portion of the Southeast Quarter of the Southwest Quarter of Section 36, Township 18 South, Range 2 West, S.B.M., according to United States Government Survey approved February 25, 1870, as more particularly described in said Right of Way Contract, for the proposed route of State Highway 11-SD-805, in said City, under the terms and conditions set forth in the form of agreement, on file in the office of the City Clerk as Document No.

739258.


2. That the Mayor and the City Clerk of The City of San Diego be, and they are hereby authorized and empowered to execute, for and on behalf of, and as the act and deed of, The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No.

739259, quitclaiming to the STATE OF CALIFORNIA, a corporation sovereign, a portion of the Southeast Quarter of the Southwest Quarter of Section 36, Township 18 South, Range 2 West, S.B.M., as more particularly

described in said form of quitclaim deed.

3. That the City Clerk is hereby authorized and directed to deliver said Right of Way Contract and said quitclaim deed, together with a certified copy of this resolution, to the Property Director of said City for further handling.
