

RESOLUTION No. 205076


Adopted by MAR 7 1972

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of BAYLOR CONSTRUCTION COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date November 17, 1971, conveying to said City an easement and right of way for street purposes through, over and across all that portion of Lot 2 in Block 4 of Rosedale, according to Map thereof No. 826, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named RUFFIN ROAD.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
