
BE IT RESOLVED, by the Council of The City of San Diego as follows:

GRANT, a married man, as his sole and separate property, as to an undivided 20% interest, executed in favor of The City of San Diego, bearing date December 2, 1971, conveying to said City an easement and right of way for water purposes, through, along and across the Northerly 35.00 feet of the East Half of the Southwest Quarter of Section 17, Township 14 South, Range 3 West, and the Westerly 50.00 feet of the Northerly 35.00 feet of the West Half of the Southeast Quarter of Section 17, Township 14 South, Range 3 West, San Bernardino Base and Meridian, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director, be, and the same is hereby approved.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
