
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of W.H.P., a joint venture, consisting of GUY HATFIELD HOMES, a California corporation, and WILLIAMSON PARK CO., a California corporation, executed in favor of The City of San Diego, bearing date November 22, 1971, conveying to said City an easement and right of way for street purposes through, over and across all that portion of Lot 65 of the Ex-Mission Lands of San Diego commonly known as Horton's Purchase according to Map thereof No. 283 filed March 9, 1878 in the Office of the San Diego County Recorder, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named MAGNUS WAY, and the land therein conveyed as Parcel 2 is hereby dedicated as and for a public street and the same is hereby named 47TH STREET.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
