APPROVING MAP OF MISSION VILLAGE UNIT NO. 23 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:


Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, Registered Civil Engineer, and entitled "MISSION VILLAGE UNIT NO. 23 Being a subdivision of portions of Lots 2, 3, 4 and 5 in Block 4 of Rosedale, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 826, filed in the office of the County Recorder of San Diego County, January 21, 1897.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public street, to wit: Ruffin Road and alley for public purposes and said street and alley are hereby declared to be public street and alley and dedicated to the public use.

BE IT FURTHER RESOLVED, that the said Council accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on said map.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council that said Council has approved said subdivision map and that said public street and alley are accepted on behalf of the public as heretofore stated; and that that certain easement with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on this map within this subdivision, is accepted on behalf of The City of San Diego, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
