

**RESOLUTION No. 205136**

Adopted on MAR 14 1972

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That an easement for the purpose of a right of way for public streets and incidents thereto; through, over, under, along and across the hereinafter described property, be, and the land therein conveyed as Parcel 1 is hereby set aside and dedicated as and for a public street and the same is hereby named VALETA STREET, and the land therein conveyed as Parcels 2 and 3 is hereby set aside and dedicated as and for a public street and the same is hereby named FAMOSA BOULEVARD:

All those portions of Pueblo Lot 206 of the Pueblo Lands of San Diego (formerly known as Collier Park) in the City of San Diego, County of San Diego, State of California, according to map thereof made by James Pascoe in 1870, a copy of which said map was filed in the Office of the County Recorder of said San Diego County on November 14, 1921 and is known as Miscellaneous Map No. 36 being more particularly described in three parcels as follows:

Parcel No. 1 (VALETA STREET):

Beginning at the most Easterly corner of said Pueblo Lot 206; thence South  $36^{\circ}03'35''$  West, 26.00 feet; thence North  $53^{\circ}55'03''$  West, 63.13 feet to the beginning of the tangent 20.00 foot radius curve, concave Southerly; thence Northwesterly, Westerly, Southwesterly and Southerly along the arc of said curve through a central angle of  $122^{\circ}41'27''$ , an arc length of 42.83 feet to a point of intersection in a 594.00 foot radius curve, concave Westerly, a radial to said 594.00 foot radius curve bears South  $86^{\circ}36'30''$  East; thence Northerly along the arc of said curve through a central angle of  $02^{\circ}36'10''$  an arc length of 26.98 feet; thence North  $00^{\circ}47'20''$  East, 42.18 feet to the point

of intersection with the Northeasterly boundary of said Pueblo Lot 206, said point for purposes of this description being hereby designated as "Point A"; thence South 53°55'03" East (Record: South 54°08'31" East) along said Northeasterly boundary 119.41 feet returning to the Point of Beginning.

Parcel No. 2 (FAMOSA BOULEVARD):

Beginning at "Point A" as set out and established in Parcel No. 1; thence North 53°55'03" West (Record: South 54°08'31" East) 17.15 feet to a point of intersection with the Southeasterly boundary of Famosa Boulevard, 80.00 feet in width, as said Famosa Boulevard was located and established prior to the date of this instrument; thence South 00°47'20" West, 52.09 feet to the beginning of a 580.00 foot radius curve, concave Northwesterly, a radial to said point bears South 89°12'40" East; thence Southerly and Southwesterly along the arc of said curve through a central angle of 35°16'15", an arc length of 357.04 feet to a point of intersection with the Southeasterly boundary of said Pueblo Lot 206; thence North 36°03'35" East, along said Southeasterly boundary 128.18 feet to the beginning of a 594.00 foot radius curve, concave Northwesterly, a radial to said point bears South 66°24'09" East; thence, leaving said Southeasterly boundary, Northeasterly and Northerly along the arc of said curve through a central angle of 22°48'31", an arc length of 236.46 feet; thence North 00°47'20" East, 42.18 feet returning to the Point of Beginning.

Parcel No. 3 (FAMOSA BOULEVARD):


Commencing at the most Easterly corner of said Pueblo Lot 206; thence South 36°03'35" West along the Southeasterly boundary of said Pueblo Lot 206, 639.65 feet to the TRUE POINT OF BEGINNING; thence continuing South 36°03'35" West, 78.52 feet to the beginning of a 580.00 foot radius curve, concave Northwesterly, a radial to said point bears South 41°19'33" East; thence Southwesterly along the arc of said curve through a central angle of 06°04'31", an arc length of 61.50 feet to a point of intersection in the arc of another 580.00 foot radius curve, concave Northwesterly, a radial to said point for last mentioned curve bears South 40°12'18" East, said point being also a point

in the Southeasterly boundary of Famosa Boulevard 80.00 feet in width as said Famosa Boulevard was located and established prior to the date of this instrument; thence Northeasterly along the arc of said curve (and along said Southeasterly boundary of Famosa Boulevard) through a central angle of  $13^{\circ}44'07''$ , an arc length of 139.04 feet returning to the TRUE POINT OF BEGINNING.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to file a certified copy of this resolution in the office of the County Recorder of San Diego County.
