

RESOLUTION NO. 205149

WHEREAS, the existing lack of public facilities, including access from Interstate 15, has resulted in a proposed building moratorium in the Mira Mesa community; and

WHEREAS, the peak hour traffic capacity of Interstate 15 is presently exceeded between Mira Mesa Boulevard and Route 163 resulting in traffic congestion and delays; and

WHEREAS, Interstate 15 widening to eight lanes is not scheduled for completion until 1977; and

WHEREAS, The City of San Diego is accelerating its efforts in freeway design review and execution of the required freeway agreements; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Council of The City of San Diego urges the California Division of Highways to expedite the expansion of Interstate 15 to eight lanes and advance construction schedules to the earliest possible date.
