RESOLUTION CREATING THE CITY COUNCIL BUDGET
REVIEW COMMITTEE.

WHEREAS, the Charter of The City of San Diego requires the City Council to prepare and adopt an Annual Appropriation Ordinance for the operation of The City of San Diego; and

WHEREAS, the City Manager is responsible for preparing and submitting to the Council a proposed budget of required expenses for conducting the affairs of the City for the ensuing fiscal year; and

WHEREAS, it is necessary for the Council to use the Manager's estimate of required expenses as a basis for preparing and adopting the Annual Appropriation Ordinance; and

WHEREAS, it is the purpose and intent of the Mayor and Council in establishing the City Council Budget Review Committee to provide a small group which can effectively analyze, study and evaluate the proposed budget of required expenses; and

WHEREAS, it is further the purpose and intent of the Mayor and Council in establishing the City Council Budget Review Committee to provide a committee of the Council for the purpose of conducting workshop sessions on the appropriation ordinance pursuant to Section 71 of the Charter of The City of San Diego; and

WHEREAS, it is further the intent of the Mayor and Council in establishing the City Council Budget Review Committee to

provide a committee of the Council for purposes of reviewing and evaluating the tentative Capital Improvements Program of The City of San Diego; and

WHEREAS, it is further the intent of the Mayor and Council in establishing the City Council Budget Review Committee to provide a small group for continuous impact and planning input on intermediate and long-range factors affecting the economic and environmental well-being of the community; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

There is hereby created the City Council Budget Review Committee composed of three voting members consisting of the Mayor, Deputy Mayor and one Councilman elected by a majority vote of the Council. The Mayor shall act as permanent Chairman. The Committee shall adopt its own rules of procedure. Such rules of procedure shall provide that other Council members participating in Committee workshop sessions shall be accorded voting privileges for said sessions similar and equal to those granted the three permanent members. The Councilman elected by the Council shall serve for a one-year period commencing on the second day of January. Each member shall serve until his successor is duly appointed and qualified. Vacancies shall be filled for the unexpired term by a majority vote of the Council.

BE IT FURTHER RESOLVED, that the City Council Budget Review Committee shall have the responsibility to analyze, study and

evaluate the estimates of required expenses proposed for inclusion in the Annual Appropriation Ordinance for The City of San Diego. The Committee shall have the further responsibility of reviewing and evaluating the tentative Capital Improvements Program of The City of San Diego. The Committee shall render such reports as may be required to keep the Council informed concerning matters considered by the Committee. The Budget Officer or his designated representative shall act as Secretary for the Committee.
