BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$89,160.52 by T. B. Penick & Sons, Inc., A Corporation, for the CONSTRUCTION OF PARKS IN CITIES (SIX (6) MINI-PARKS), including Base Bid and Additive Alternates A, B-a and C-a, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 738776.
2. That the expenditure of \$109,800 is hereby authorized out of the Capital Outlay Fund (245) of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF PARKS IN CITIES (SIX (6) MINI-PARKS), including Base Bid and Additive Alternates A, B-a and C-a, in the City of San Diego, and related costs.
