APPROVING MAP OF UNIVERSITY GARDENS UNIT NO. 2 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by RICHARD T. STANDISH, R.C.E., and entitled "UNIVERSITY GARDENS Being a subdivision of portions of Pueblo Lots 1246, UNIT NO. 2 1247 and 1274 of Pueblo Lands of San Diego, in The City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, a copy of which Map was filed in the office of the County Recorder of San Diego County and is known as Miscellaneous Map No. 36.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets, to wit: Lakewood Street, Nanette Lane, Via Papel and Maynard Street for public purposes and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of The City of San Diego, a municipal corporation, those easements for general utility and access purposes; for sewer and drainage purposes, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of The City of San Diego, a municipal corporation, the open space easements over portions of Lots 13, 19, 26, 32 36, 40, 44, 54, 60, 68, 69 and 70, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and those easements for general utility and access purposes, sewer and drainage purposes, and open space, listed in the certificate signed by the Owners, subject to the conditions expressed therein, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
