AND ASSOCIATES, for professional services required in connection with the development of Paradise Hills Park and Recreation Center - Recreation Building, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 739434.

BE IT FURTHER RESOLVED, that the expenditure of \$20,000 is hereby authorized from the Park and Recreation Bond Fund 725, solely and exclusively for the purpose of providing funds for this purpose and related design and construction costs.
