George F. Bell	POLICE DEPARTMENT	\$50	This is an additional amount to the original \$10 award made for this suggestion. The application of the route slip procedure for notify warrants was extended during the year that it was begun, resulting in about \$500 in additional savings.
Thomas J. Olson	PUBLIC WORKS - CITY ENG.	\$30	This Equipment Serviceman proposed the use of automatic tire inflators at the three equipment service stations. These are now in use to save time and for a much safer operation.
Richard H. Fisher	PUBLIC WORKS - CITY ENG.	\$10	An improved form was designed to accompany equipment parts from one service station to another. This results in prevention of loss of the parts and better information in regard to them.
