That the expenditure of \$25,000.00 is hereby authorized out of the Flood Control & Storm Drain Bond Fund (727) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF ESSEX STREET STORM DRAIN FROM UNIVERSITY AVENUE TO ROBINSON AVENUE in the City of San Diego, and related costs.
