

RESOLUTION No. 205197

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by The City Manager of that deed of RAYMOND E. CULVER and MARY E. CULVER, his wife, executed in favor of The City of San Diego, bearing date of February 25, 1972, conveying to said City an easement and right of way for street purposes through, over and across all that portion of Lot 16, Block 36 of Paradise Hills Unit No. 2, according to the Map thereof No. 2068, filed October 29, 1927, in the Office of the San Diego County Recorder, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named CHATTANOOGA STREET.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
