That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with WILLIAM A. LAW & ASSOCIATES for the engineering design of traffic signals and safety lighting systems at two locations, Appleton Street-Genesee Avenue-Lehrer Drive and Felspar Street-Ingraham Street, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 739440.

BE IT FURTHER RESOLVED, that the expenditure of \$2,650 is hereby authorized from Gas Tax Fund 220 solely and exclusively for the purpose of providing funds for the engineering design of traffic signals and safety lighting systems described above and related costs.
