That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a first amendment to agreement with INTER-CITY ENGINEERS, INCORPORATED, a California corporation, amending the agreement on file in the office of the City Clerk as Document No. 737032 dated August 12, 1971, for engineering services in connection with design and construction of Linda Vista Road from Morena Boulevard to 2,000 feet easterly of Via Las Cumbres Avenue, under the terms and conditions set forth in the form of first amendment to agreement on file in the office of the City Clerk as Document No. 739441.

BE IT FURTHER RESOLVED, that the expenditure of \$1,800 is hereby authorized from Gas Tax Fund 219 solely and exclusively for the purpose of providing funds for the engineering services described above, and that Resolution No. 203 437 be supplemented in that amount.
