BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$31,377.69 by Nelson Construction Co., Inc., a corporation, for the CONSTRUCTION OF CALLAN SEWER MAIN FROM SCIENCE PARK SEWER TO THE CALLAN TREATMENT PLANT in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 738595.
2. That the expenditure of \$38,500.00 is hereby authorized out of the Sewer Revenue Fund (506) of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF CALLAN SEWER MAIN FROM SCIENCE PARK SEWER TO THE CALLAN TREATMENT PLANT in the City of San Diego, and related costs.
