WHEREAS, C & W PROPERTIES, a partnership, Owner, hereafter referred to as "Permittee," filed an application for a land conservation permit to develop the property located on the west side of Laurie Lane, between Laurel Street and Home Avenue, more particularly described as Lots 13 through 16, Block 19, Swan's Addition, in the R-4 (LC Overlay) Zone; and

WHEREAS, on February 16, 1972, the Planning Commission of The City of San Diego made its findings of facts; granted a land conservation permit to Permittee; and filed the decision in the office of the City Clerk on March 2, 1972; and

WHEREAS, pursuant to the provisions of Section 101.0454 of the San Diego Municipal Code, HOME OWNERS-LAURIE LANE, LAUREL STREET, 44TH STREET AND HIGHLAND AVENUE, by Terry J. Barrett, appealed the decision of the Planning Commission on February 28, 1972; and

WHEREAS, said appeal was set for public hearing on March 30, 1972, testimony having been heard, evidence having been submitted and the City Council having fully considered the matter and being fully advised concerning the same; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

All of the following facts exist with respect to the issuance of Land Conservation Permit No. 6 on the property described in

the preamble of this resolution:

- 1. The development will result in minimum disturbance of the natural terrain commensurate with the proposed use of the lot or premises.
- 2. Grading and excavation proposed in connection with the development will not result in soil erosion, silting of lower slopes, slide damage, flooding problems, or severe cutting or scarring.
- 3. The proposed development will serve to preserve and enhance the natural environment and the aesthetic qualities of the site.

The above findings are further supported by the minutes, maps, tape of the proceedings and exhibits, all of which are herein incorporated by reference.

BE IT FURTHER RESOLVED, that by a vote of 8 to 0, the appeal of HOME OWNERS-LAURIE LANE, LAUREL STREET, 44TH STREET AND HIGHLAND AVENUE, by Terry J. Barrett, be and it is hereby denied, and the City Council does hereby grant to C & W PROPERTIES, Permittee, Land Conservation Permit No. 6 in the form and with the terms and conditions as set forth in the permit attached hereto and made a part hereof.

GENERAL CONDITIONS FOR LAND CONSERVATION PERMITS

- 1. Prior to the issuance of any building permits, complete grading and building plans shall be submitted to the Planning Director for approval. Plans shall be in substantial conformity with Exhibit A, dated February 16, 1972, on file in the office of the Planning Department. The property shall be developed in accordance with the approved grading and building plans except where regulations of this or other governmental agencies require deviation therefrom. Prior to and subsequent to the completion of the project, no changes, modifications or alterations shall be made unless and until appropriate applications for amendment of this permit shall have been approved and granted.
- 2. Prior to the issuance of any grading or building permits, a complete landscaping plan, including a permanent watering system, shall be submitted to the Planning Director for approval.

 Said plans shall be in substantial conformity with Exhibit A, dated February 16, 1972, on file in the office of the Planning Department and shall be in accordance with the Land Development Ordinance No. 10660 (New Series). Approved planting shall be installed prior to the issuance of an occupancy permit on any building. Such planting shall not be modified or altered unless and until this permit shall have been amended to permit such modification or alteration.
- 3. Construction and operation of the approved permit shall comply at all times with the regulations of this or other governmental agencies.

- 4. The effectiveness of this land conservation permit is expressly conditioned upon, and the same shall not become effective for any purpose unless and until the following events shall have occurred:
 - a. Permittee shall have agreed to each and every condition hereof by having this permit signed within 90 days of the Council's decision.
 - b. This land conservation permit executed as indicated shall have been recorded in the office of the County Recorder.
- 5. In addition to any other remedy provided by law, any breach in any of the terms or conditions of this permit or any default on the part of Permittee or its successors in interest, shall be deemed a material breach hereof and this land conservation permit may be cancelled or revoked. Cancellation or revocation of this permit may be instituted by the City or Permittee. The Planning Director shall set this matter for public hearing before the Planning Commission giving the same notice as provided in Section 101.0506. An appeal from the decision of the Planning Commission may be taken to the City Council within ten days after the decision is filed with the City Clerk. The Clerk shall set this matter for public hearing before the City Council giving the same notice as provided in Section 101.0506.
- 6. This land conservation permit shall inure to the benefit of and shall constitute a covenant running with the lands, and

the terms, conditions and provisions hereof shall be binding upon Permittee, and any successor or successors thereto, and the interests of any successor shall be subject to each and every condition herein set out.
